Board of Directors Meeting Minutes November 14, 2006

Minutes from a Board of Directors Meeting of The Masters At Pelican Sound Neighborhood Association, Inc. held on November 11, 2006 at the Pelican Sound River Clubhouse in Estero, Florida.

<u>Call to Order:</u> The meeting was called to order by John Phillips at 9:00 A.M.

Reading or waive reading of previous minutes: Jeannine Hedberg read the minutes of October 24, 2006 Board of Directors Meeting. A motion was made by Joan Roeske and seconded by Marcy Holtz to approve the minutes as amended. **VOTE:** all in favor/motion passes.

<u>Treasures Report:</u> George Bigg reported that the association is in a good cash position, with \$73,547.00 in reserves. For the eight months ending in August 2006, the association is ahead of its budget. This is compared to last year where the association had a loss of \$13,000.00. George is working with Steve Hart of Collier Financial to finish the proposed budget for 2007.

Proposed Budget 2007: Steve Hart, Collier Financial: Line Items Discussed:

- 1. Accounting increased costs to Collier Financial
- 2. Insurance Nationwide, non-renewal. New proposals will increase to \$3700 or so.
- 3. Irrigation Maintenance 1st year of three-year project to r??? the sprinkler heads.
- 4. <u>Landscaping contract</u> Greenscapes/\$127.98 per residence per month. Slight decrease because there is no cushion.
- 5. Plant replacement Category eliminated
- 6. Legal Will remain \$1500 as it was last year
 - a. Rewriting the Association Documents/\$5,000 to cover expenses.
 - b. Approx. \$1500 spent in 2006 and approx. \$3,500 in 2007
- 7. Misc. Same
- 8. Office/Postage \$4,100 this year. Increase to \$5,000 to cover copies and mailing of docs.
- 9. Property Management Fees \$9,000/a \$600 increase has been requested.
- 10. Rodent Control \$10,800/\$900 monthly no change.
- 11. <u>Irrigation Reserve</u> \$5,400 this year, lowered to \$4,800 (based on replacing clocks, solenoids over 6.7 years)

- 12. Roof Cleaning/Painting \$4,750 per year. Paint in 2011.
- 13. Interest on Reserves Sweep into actual Reserves.
- 14. Federal Tax Budgeted 2006/\$400, actual/\$721. To be increased to \$800.
 - a. Surplus of \$19,800 at end of year. To keep amounts the same, suggested to use \$7,000 of the surplus amount.
- 15. Live Oak Trimming Accept proposal #19816?
- 16. Reserves All reserves are being funded.
 - Maintenance fee for 2007 per quarter will stand at \$604.
 - Collier Financial will mail proposed budget to all owners 14 days in advance of meeting on Dec. 5, 2006 at 1:00 PM in the Riverside Room

<u>Managers Report:</u> Information package to owners – tabled indefinitely.

Director Reports: None

Old Business:

- A. **By-Law Modification:** By-laws are close to completion. Joan's committee will be meeting to go through the issues.
- B. <u>Carriage Lamp walkthrough</u>: The walkthrough to look at all carriage lamps is scheduled for November 30, 2006. All carriage lamps need to be repainted, or replaced by this time.
- C. **Greenscapes:**
 - a. Proposing a bi-monthly walkthrough for our community. This may not be enough in season.
 - b. Paradise Management will check on the timing of the palm trimming for the community.
 - c. Greenscapes has two invoices for emergency calls to repair running water leaks on Sundays. Who is responsible for this expense. It is not defined in the contract.
 - d. Walk through Marcy, Joan and John possibly November 30 in the morning.

New Business: None

- 1. Pete Bodnar: Asked if the Rodent control program should be suspended and asked if the community should be polled?
- 2. Bill Karlen: Comment to rodent issue when the palmettos are cut, they will come to our area again.
- 3. Massey Pest: Did not call last month. Ask Massey how a program would need to be restarted. Jeannine will walk through with Massey the next time.
